# THE CHALLENGE

The challenge for Hazell Bros was to replace FRx Reporter, a tool that had served them well, but was past its sunset date. Recognizing the risk of running non-supported software, Hazell began evaluating alternatives. However, the reporting solutions they found either didn't meet their requirements or were overly complex.



Hazell needed multi-entity consolidation and reporting to manage their nine business units. At the same time, they wanted users to be self-sufficient, minimizing the need for both manual touchpoints and outside support. The new reporting tool also needed to work with any ERP system, allowing the company to shift, grow, and scale as needed.

## THE SOLUTION

Hazell Bros chose Solver because it provided multi-entity financial and regulatory reporting, without being overly complex or expensive. Solver's cloud-based architecture provided the flexibility and scalability needed to future-proof business operations.



## How did Solver perform versus expectations?

Their concrete business, for example, uses concrete volume to calculate costs and revenue. By understanding the business drivers for each business area, managers can use language and metrics that make sense to them.
